## PIG 'N MUD WRESTLING RULES

1. Sponsor or team captain is responsible for the actions of the team.
2. Team consists of Four (4) members.
3. All players must start by having one hand on the fence between entry gate and orange ribbon on fence.
4. There will be two (2) players on each side of the entry gate.
5. No player may use gloves, spikes, hooks, or any other object to help catch a pig.
6. Pig must be put in the barrel butt first.
7. No hitting pig to start or otherwise harm the animal.
8. Barrel must be upright at all times.
9. There will be a one minute time limit on each match.
10. All players must raise both hands in the air to complete the match.
11. Players must stay and help unload the pig out of the barrel.
12. All players must wear shirt, pants and shoes for safety reasons.
13. All contestants MUST sign a release form. Anyone under age 18 MUST have a parents signature before the entry form will be accepted.
14. There must be a team name or sponsor listed and the money must accompany the form or the entry will not be accepted.
15. All contestants MUST stay out of the grandstand seating areas and grandstand restrooms after competing.
16. CO-ED teams allowed only for Pee-Wee and Jr. Divisions.
17. **If registration deadline is met, gate admission is "Free" for that team.**
18. **There will be a limit of 55 teams.**
19. **Entry fees will be paid to 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place winners.**
20. The judge's ruling is final!
21. Trophies will be awarded to each team member of each division for "Best Dress".

# RELEASE

**RELEASOR** agrees to indemnify the **RELEASEES** and each of them from any loss, liability, damage or cost they may incur due to the presence of **RELEASOR** in or upon the areas where the hog wrestling activities will take place, whether caused by the negligence of the **RELEASEES** or otherwise.

**RELEASOR** hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of **RELEASEES** or otherwise while in or upon the areas where the hog wrestling activities will take place and while participating in the hog wrestling activities.

**RELEASOR** expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Idaho and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. **RELEASOR** expressly understands that the hog wrestling involves an inherent risk of injury to oneself and to others. **RELEASEES** are not liable for the injuries to those who participate in hog wrestling activities, or that are caused by watching the hog wrestling activities.
